WARRANT TO TAKE PHYSICAL CUSTODY OF CHILD (UCCJEA)

THE STATE OF WISCONSIN TO ANY LAW ENFORCEMENT OFFICER — GREETINGS:

A verified petition having been filed in this Court, pursuant to the *Uniform Child Custody Jurisdiction and Enforcement Act* (Wis. Before being removed from the abduction location, however, each child shall, if possible, be evaluated and counseled by a CPS worker, social worker or other mental health professional who will help the child pack and prepare to leave.

YOU ARE FURTHER COMMANDED THAT

in conjunction with the local child protective service, each child named above shall be placed, pending final relief, as follows [specify]:
