Stats. §822.42*, and the court may schedule a hearing to determine whether further relief is appropriate, unless the respondent appears and establishes either that:**

1. The child custody determination has not been registered and confirmed under *Wis. Stats §822.35*, **and** that either
  - (a) the issuing court did not have jurisdiction under *Wis. Stats. ch. 822, subchapter II*; or
  - (b) the child custody determination has been vacated, stayed, or modified by a court having jurisdiction to do so under subch. II of *Wis. Stats. Ch. 822*; or
  - (c) the respondent was entitled to notice, but notice was not given in accordance with the standards of *Wis. Stats. §822.08 in the proceedings before the court that issued the child custody determination for which enforcement is sought*; OR
2. The child custody determination for which enforcement is sought was registered and confirmed under *Wis. Stats. §822.35*, but has been vacated, stayed, or modified by a court of a state having jurisdiction to do so under subch. II of *Wis. Stats. Ch. 822*.
